Department carrying the scale of pay in Level-12 of pay matrix provided under Rule-3 of ORSP Rules-2017 corresponding to pre-revised scale of Pay Band-3 (Rs.15,600-Rs.39,100/-) carrying Grade Pay of Rs. 5,400/- with usual dearness allowance and other allowances as may be sanctioned by the Government of Odisha from time to time.

2. VACANCY POSITION: As per requisition furnished by the Housing & Urban Development Department, Government of Odisha, the vacancy position for the post of **Assistant Executive Engineer (Civil)** is **46(15-w)**. Out of which 24(08-w) vacancies are for UR category, 05(02-w) vacancies are reserved for SEBC category, 07(02-w) vacancies are reserved for SC category and 10(03-w) vacancies are reserved for ST category. Also, 02 posts are reserved for PwDs whose permanent disability is 40% or more. Candidates belongs to the categories of PwDs shall be adjusted against the categories to which belong.

3. AGE: A candidate must have attained the age of **21 (twenty-one)** years and must not be above the age of **42 (Forty-two)** years on **1st day of January, 2026** i.e. he/she must have been born **not earlier than 2nd January 1984** and **not later than 1st January 2005**.

4. EDUCATIONAL QUALIFICATION: A candidate must be **Graduate in Civil Engineering** from any University or Institution recognized by the Government or he/she must be an **Associated Member of the Institution of Engineers of India in Civil**.

5. EXAMINATION FEE: The candidates other than SC, ST and PwD category shall have to pay the examination fee amounting to **Rupees Seven Hundred (₹700/-) only** through online mode while filling the Online Application Form. The examination fees paid shall be **refunded only to those candidates who actually appear in the Preliminary Examination. Applications without payment of examination fees (except SC/ ST/ PwD candidates) will be taken as incomplete and outrightly be rejected.**

Refund shall be issued in due course after completion of the Preliminary Examination. Refunds will be processed to the original mode of payment used at the time of the transaction by the candidate. (Credit Card, Debit Card, UPI, Wallet, etc.)

6. METHOD OF SELECTION: The selection of candidates for recruitment to the posts of **Assistant Executive Engineer (Civil)** shall be made through competitive examination to be conducted in three stages; viz-**Preliminary Examination, Main Examination and Interview.**

The link for Online Application and Submission shall be available from **11.08.2026 to 11.09.2026 (5.00 P.M.)** (Note: **11.09.2026 (5.00 P.M.)** is the last date /closing date for submission of Registered Online Application) for recruitment to **46 (Forty-Six)** posts of **Assistant Executive Engineer (Civil)** in Group-A of Odisha Municipal Engineering Service cadre under H & U.D Department carrying the scale of pay in Level-12 of pay matrix provided under Rule-3 of ORSP Rules-2017 corresponding to pre-revised scale of Pay Band-3 (Rs.15,600-Rs.39,100/-) carrying Grade Pay of Rs. 5,400/- with usual dearness allowance and other allowances as may be sanctioned by the Government of Odisha from time to time. The recruitment is to be conducted according to the provisions mentioned in the Odisha Municipal Engineering Services (Recruitment and Conditions of Service) Rules, 2016.

2. Vacancy Position: As per requisition filed by the Housing & Urban Development Department, Government of Odisha, the vacancy positions are mentioned below:

Out of the total 46 (15-W) number of vacancies mentioned above, the reservation of vacancies in respect of **Persons with Disabilities (whose permanent disability is 40% or more)** are given below. Persons with Disabilities shall be adjusted against the categories to which they belong.

NOTE:

- The candidates applying against SEBC Category (Non-Creamy Layer) must submit Caste Certificate issued by the Competent Authority not more than 03 years before the date of submission of Online Application Form. Candidates furnishing SEBC certificate which is issued more than 03 years prior to the date of submission of Online Application, shall not be considered under SEBC category.
- PwD Candidates must upload their Permanent Disability Certificate. Certificate showing Temporary Disability will not be accepted and the application shall be liable for rejection.
- Experience has shown that, some candidates obtain SC/ST/SEBC certificate etc. immediately ahead of the date of Application and upload the same along with Online Application, only to secure admission to the examination, which sometimes get cancelled subsequently on the grounds of inadmissibility or fraud etc. If any such cancellation of any uploaded certificate is detected at any stage of the recruitment examination, the candidature of such candidates will be cancelled under that category and punitive measure as deemed shall be taken against him/her.
- In the event of non-availability or availability of insufficient number of eligible women candidate(s) belonging to any particular category, the remaining vacancies will be filled up by male candidate(s) of that category.
- Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered in the event of non-availability of eligible and suitable S.C./S.T. candidates.
- The number of vacancies to be filled up on the basis of this recruitment is subject to change by Government without notice, depending upon the exigencies of public service at the discretion of the State Government.

3. AGE: A candidate must have attained the age of **21 (Twenty-one)** years and must not be above the age of **42 (Forty-two)** years on the **1st day of January, 2026** i.e. he/she must have been born **not earlier than 2nd January 1984 and not later than 1st January 2005**.

The upper age limit prescribed above shall be relax-able by **5 (five) years** for candidates belonging to the categories of SC/ST/SEBC/Women and Ex-Servicemen and by **10 (ten) years** for Persons With Disabilities, whose permanent disability is 40% or more.

Persons with Disabilities belonging to the categories of SC/ST/SEBC shall be entitled to cumulative age relaxation benefit of 15(Fifteen) years.

Although age relaxation is permissible to Persons with Permanent Disabilities, reservation of post is only meant for persons with permanent disabilities belonging to Cat-I & Cat-II as requisition by the Government.

Provided that a candidate who comes under more than one category mentioned above he/she will be eligible for only one benefit of upper age relaxation, which shall be considered most beneficial to him/her.

(SAVE AS PROVIDED ABOVE THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED.)

Date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council will only be accepted by the Commission.

4. EDUCATIONAL QUALIFICATION:

A candidate must be **Graduate in Civil Engineering** from any University or Institution recognized by the Government or he/she must be an **Associated Member of the Institution of Engineers of India in Civil.**

5. EXAMINATION FEE:

As per Odisha payment of recruitment examination fees and Refund Rules, 2025 published vide Government in G.A. & P.G. Department Notification No. 34124-GAD-SC-rules-0020/2025/Gen. dated 10.10.2025, the candidates other than SC, ST and PwD category shall have to pay the Examination fees.

The candidates other than SC, ST and PwD category shall have to pay the examination fee amounting to **Rupees Seven Hundred (₹700/-) only** through online mode while filling the Online Application Form.

The examination fees paid shall be **refunded only to those candidates who actually appear in the Preliminary Examination. Applications without payment of examination fees (except SC/ ST/ PwD candidates) will be taken as incomplete and outrightly be rejected.**

Refund shall be issued in due course after completion of the Preliminary Examination. Refunds will be processed to the original mode of payment used at the time of the transaction by the candidate. (Credit Card, Debit Card, UPI, Wallet etc.)

However, the candidates shall have to furnish their bank account details i.e. Account Number, IFSC Code, Name of the Account Holder and Name of the Bank branch in the required field in the Online Application Form which will be required in case of failure of refund of money through the original mode of payment owing to technical glitches or other issues, if any. The Bank Account must remain valid/active. The onus of furnishing the correct bank account details lies with the candidates and the Commission (OPSC) shall not entertain any correspondence from any candidate in this regard.

6. METHOD OF SELECTION:

The selection of candidates for recruitment to the posts of **Assistant Executive Engineer (Civil)** shall be made through competitive examination to be conducted in three stages; viz-**Preliminary Examination, Main Examination** and **Interview**.

A. PRELIMINARY EXAMINATION:

- i. The Preliminary Examination shall be a screening test for shortlisting candidates for admission to the Main Examination.
- ii. It shall consist of one paper in Civil Engineering comprising Objective Type Multiple Choice Questions (MCQs), to be conducted either through Optical Mark Recognition (OMR) based Evaluation or Computer-based Test (CBT), as may be decided by the Commission.
- iii. The paper shall carry 100 marks comprising 100 questions, each carrying one mark.
- iv. One mark shall be awarded for each correct answer.
- v. There shall be negative marking. For every incorrect answer, 25% of the marks allotted to the question shall be deducted.
- vi. No mark shall be awarded or deducted for un-attempted questions.
- vii. The duration of the examination shall be one and half hours.
- viii. The minimum qualifying marks for the Preliminary Examination shall be determined by the Commission separately for each category of candidates.
- ix. Candidates securing the minimum qualifying marks as fixed by the Commission shall be shortlisted for admission to the Main Examination, in order of merit, subject to a maximum of approximately 10 times to the number of vacancies notified for each category.
- x. The marks obtained in the Preliminary Examination shall not be taken into account for preparation of Final Merit List or recommendation for appointment.

B. MAIN EXAMINATION:

The Main Examination will consist of 500 Marks and the Personality Test/ Interview of 50 Marks as follows:

The marks secured by the candidates out of the 550 marks will be counted in drawing the final Merit List for recommendation of appointment (Select List).

MAIN EXAMINATION:

- i. The Main Examination will be conducted in **2 (Two) Papers** of **Total 500 Marks** (Paper-I-200 marks and Paper-II-300 marks) of Objective Type Multiple Choice Questions (MCQ Pattern) with Optical Mark Recognition (OMR) Evaluation or Computer-based Test (CBT) to be decided by the Commission.
- ii. Paper-I (General Studies) will consist of 200 marks with 100 questions and Paper- II (Civil Engineering) will consist of 300 marks with 150 questions each carrying two marks.
- iii. For each correct answer, two marks will be awarded.
- iv. There will be a negative marking. For each wrong response, **25% marks will be deducted** from the marks secured for correct answers.
- v. For un-attempted questions, "zero" mark will be awarded.
- vi. The duration of the Main Examination will be 2 (two) hours for Paper- I and 2 & ½ (two and half) hours for Paper-II.
- vii. The Commission will fix qualifying marks for each Paper and/or aggregate for each category of candidates.
- viii. Candidates who secure minimum **qualifying marks** as fixed by the Commission will be shortlisted in the ratio of **1:2 subject** to a minimum of 5 (five) with reference to the number of vacancies in the different categories to appear for the Personality Test/Interview.

C. INTERVIEW:

The Interview will carry **50 Marks**.

D. SELECT LIST:

- i. The final Merit List for recommendation of appointment (Select List) will be prepared based on the marks obtained by the candidates in the Main Examination and Personality Test/Interview taken together for different categories equal to the total number of vacancies for each category of candidates to be filled in the year through this examination.
- ii. If more than one candidate secure equal marks in the aggregate, the candidate securing higher marks in the Main Examination will be placed higher in the merit list. In case of further tie, the order of merit shall be arranged in order of the date of birth, i.e., the older in age will be placed higher in the merit list than the younger.

E. SYLLABUS:

The Papers and Syllabus of the Preliminary and Main Examination are appended at Appendix-A and Appendix-B.

NOTE: Details relating to this recruitment like mark secured by Last Selected Candidate (LSC mark), individual marks, etc. shall only be declared in the Website of the Commission after publication of the Final Result and Select List.

7. PLACE OF EXAMINATION:

The Preliminary/Main Examination will be held at Kataka. It may also be held at Bhubaneswar, Baleshwar, Brahmapur, Sambalpur, Jayapur depending on the number of candidates applied from the respective zones as decided by the Commission.

The candidates are to mention their choice of examination zone at appropriate place in the Online Application Form.

8. DATE OF EXAMINATION:

The Preliminary Examination will be held on **08.11.2026(Sunday)**. The detailed Schedule and Centre of Examination will be notified in due course.

After completion of the Preliminary Examination, the Provisional Answer Key to the Paper shall be uploaded in the website within 10 days of the examination, inviting suggestions/objections, if any, from the candidates. Those candidates who do not challenge the Provisional Answer Key shall forfeit their right to agitate the matter subsequently in any forum in any other manner.

9. OTHER ELIGIBILITY CONDITIONS:

- i. The candidate must be a citizen of India;
- ii. He/ She must be of (a) good moral character, and (b) good mental condition and bodily health and free from physical defects or bodily infirmity so as not to create an impairment in the due discharge of duties in the service. Provided that this clause, except good mental condition shall not be applicable to the persons with disabilities;
- iii. He/She must be able to read, write and speak Odia and must have -
 - (a) Passed Middle School examination with Odia as a language Subject; or
 - (b) Passed Matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
 - (c) Passed in Odia as language subject in the final examination of Class-VII or above from School or Educational Institution recognized by the Government of Odisha or the Central Government; or
 - (d) Passed a test in Odia in Middle English School Standard conducted by the School and Mass Education Department/Board of Secondary Education, Odisha
- iv. A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- v. Government servants, whether temporary or permanent, are eligible to apply provided that, they possess the requisite qualification and are within the Prescribed age-limit as provided under **Para-4 & Para-3** of the Advertisement respectively. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "**No Objection Certificate**" during document verification. So, the candidates must obtain NOC well in advance;

- vi. If a candidate has at any time, been debarred for a certain period/chance(s) by the Odisha Public Service Commission or other State Public Service Commissions or U.P.S.C. from appearing at any examination / Viva Voce test, he/she **will not be eligible** to apply for that specified period / chance(s);
- vii. **Only those candidates, who possess the requisite qualifications, are within the prescribed age limit and fulfill other eligibility conditions strictly etc. by the closing date for submission of registered online application form, will be considered eligible;**
- viii. Every candidate selected for appointment shall be examined by the Medical Board and any candidate who fails to qualify the Medical Board shall not be eligible for appointment.

10. IMPORTANT POINTS:

- i. A candidate found guilty of seeking support for his/her candidature by offering illegal gratification or applying pressure on any person connected with the conduct of the recruitment process or found indulging in any type of malpractice in course of the selection or otherwise, shall, in addition to rendering himself/herself liable to criminal prosecution, be disqualified not only for the recruitment for which he/she is a candidate, but also may be debarred, either permanently or for a specified period, from any recruitment or selection to be conducted by the Commission;
- ii. The provisions of the Odisha Conduct of Examination Act 1988 (Odisha Act-2 of 1988) are applicable to the examination conducted by the Odisha Public Service Commission.
- iii. **Online applications submitted to OPSC, if found to be incomplete in any respect, are liable for rejection without entertaining any correspondence with the applicants on the score;**
- iv. **Admission to the Main Examination will be provisional. If on verification at any stage before or after the Main Examination/Document Verification/Publication of Result, it is found that a candidate does not fulfil all the eligibility conditions, his/her candidature will be liable for rejection. Decision of the Commission in regard to eligibility or otherwise of candidate shall be final;**
- v. This advertisement should not be construed as binding on the Government to make appointment;
- vi. **Reservation and Relaxation etc. meant for S.C/S.T. by Birth and SEBC are admissible to the Scheduled Castes/Scheduled Tribes and Socially & Educationally Backward Classes of Odisha Only;**
- vii. Community (caste status) once mentioned by the candidates under the appropriate box of the online application form, will be treated as final and the same not be changed subsequently under any circumstances.
- viii. Any misrepresentation or suppression of information by the candidate in the online application form will result in cancellation of his/her candidature or penalty, as decided by the Commission shall be imposed on the candidate.
- ix. Mere empanelment in the Select List shall not confer any right for appointment unless the Government is satisfied after making such enquiry as may be deemed necessary that the candidate is suitable in all respects for appointment to the service.

- x. A candidate who claims change in his/her name after having passed the H.S.C. examination, is required to furnish copy of publication of the changed name in the local leading daily newspaper as well as copy of notification in the Gazette in support of his/her change of name;
- xi. All persons appointed under the Government of Odisha on or after 1st January, 2005 shall not be eligible for pension as defined under Sub-rule (1) of Rule-3 of the Odisha Civil Service (Pension) Rules, 1992; but shall be covered by the defined Contributory Pension Scheme in accordance with the Odisha Civil Services (Pension) Amendment Rules, 2005;
- xii. **Submission of NPS application is mandatory for all recommended candidates at the time of joining in Government services.**

11. CERTIFICATES / DOCUMENTS TO BE UPLOADED AS WELL AS SUBMITTED AT THE TIME OF DOCUMENT VERIFICATION, IF CALLED FOR:

While submitting online application, the candidates are advised to upload all the following original scanned documents/certificates in the e-Chayan portal of the Commission.

- (i) H.S.C. or equivalent certificate in support of declaration of age issued by the concerned Board/Council;
- (ii) Intermediate/+2 Sc. Pass Certificate issued by the concerned University/Council;
- (iii) Degree (i.e. Engineering in Civil) pass certificate issued by the recognized University or AMIE of India in Civil;
- (iv) Mark-lists of all semesters/annual examinations in support of Degree (Engineering in Civil) passed including fail marks, if any, issued by the concerned Board/Council/University;

NOTE-1: (a) Candidates who have not been awarded percentage of marks, but only grade marks, should along with their applications, produce the conversion certificates from the concerned University including the actual equivalent percentage of marks and the conversion formula, failing which, their applications are liable to be rejected.

(b) While filling up the marks in the online application form; the candidate has to mention the additional marks secured by him/her in each Semester/Annual Examination in the HSC, +2 and Degree (excluding the marks secured in the Extra Optional Paper).

- (v) Required Odia Test Pass Certificate.
- (vi) Caste certificate by birth in support of claim as S.E.B.C/S.C/S.T. (**Please see Note-2**)
- (vii) Persons with Disabilities are required to submit/upload Permanent Disability Certificate (indicating percentage of permanent disability i.e. 40% or more) issued by the concerned Medical Board wherever applicable;
- (viii) **Ex-Servicemen are required to submit/upload Release Certificate issued as per Orissa Ex-Servicemen (Recruitment to State Civil Services and Posts) Rules, 1985 vide G.A. Department notification No.22586-Gen., dt.16.10.1985.**
- (ix) No Objection Certificate issued by the Competent Authority/Head of Office; wherever applicable;
- (x) Four recent passport size photographs within 06 months (unsigned and unattested) which has been uploaded in the online application form;
- (xi) Proof of identity i.e. Aadhar / EPIC/ DL/ Passport/PAN Card.

- (xii) **The Third Gender/Transgender candidates shall upload their Identity Card/Card Issued by a Competent Authority as well as requisite document in support of change of their name on getting the Third Gender/Transgender Status, if any.**

Also, the candidates who qualify in the written examination, shall be required to bring with them the hard copy of online application form along with copies of following relevant uploaded certificates/documents and originals of the same for verification of their eligibility as per terms and conditions of the advertisement, the date of which will be notified later on in due course, failing which his/her application will be rejected for the said post. The candidates are required to mention on each copy of documents **"Submitted by me and Certified as genuine and has not been cancelled"** and put their **full signature and date on the same**. They must not attach the original certificate to their application.

NOTE-2: (a) Candidates claiming to be belonging to S.C. /S.T. categories of Odisha by birth and S.E.B.C. are required to submit copy of the relevant Caste Certificate issued by the Competent Authority in the prescribed form.

(b) The candidates applying against SEBC Category (Non-Creamy Layer) must submit Caste Certificate issued by the Competent Authority not more than 03 years before the date of submission of online application form. For example, if a candidate is submitting the online application on 26.01.2026; the SEBC certificate must have been issued on or after 27.01.2023. If such certificate is issued before 27.01.2023 will not be treated as valid and the candidate will not be considered under SEBC category.

(c) Women candidates belonging to S.E.B.C. / S.C. / S.T. categories are required to submit Caste Certificates showing **"daughter of"**. Caste Certificates by virtue of marriage (i.e. showing **"wife of"**) are not acceptable and liable for rejection.

(d) OBC certificate will not be accepted in lieu of SEBC certificate.

(e) Community (Caste status) once mentioned by the candidates in the online application form shall not be changed under any circumstances.

The Competent Authorities are as prescribed by the Government of Odisha under relevant Reservation Rules.

NOTE-3: Degree certificate, Caste Certificate, Odia Test Pass Certificate, Permanent Disability Certificate of Person with Disabilities (indicating % of permanent disability) and Release Certificate of Ex-Serviceman [issued as per Orissa Ex-Servicemen (Recruitment to State Civil Services and Posts) Rules, 1985 vide G.A. Department notification No.22586-Gen., dt.16.10.1985] must have been issued by the Competent Authority on or before **the date of submission of the registered Online Application form by the candidate**. Any such certificate issued after the last date for submission of Online Application Form will not be entertained to consider eligibility.

12. GROUND'S OF REJECTION OF APPLICATIONS:

Applications of candidates will be rejected by the Commission on any of the following grounds: -

- (a) Incomplete online application form.
- (b) Non-submission of hard copy of online application form at the time of verification of original documents.
- (c) Not signing Declaration (full signature) in the hard copy of online application form.

- (d) Not passing Odia Test (M.E standard)/not furnishing Odia Test Pass evidence by the date for submission of registered online application form as required under Para-9 (iii) of the Advertisement.
- (e) Not coming within the age limit as mentioned in Para - 3 of Advertisement.
- (f) Not having requisite qualification by the date of submission of registered Online Application Form as provided under Para - 4 of Advertisement.
- (g) Not furnishing copies of certificates/documents as provided under Para – 11 of Advertisement.

1. SOLID MECHANICS:- Elastic constants, plane stress, plane strain, Mohr's circle, combined stress; Elastic theories of failure; Simple bending, Shear; Torsion of circular and rectangular sections and simple members. Bending Moment and Shear Force in statically determinate beams.

2. STRUCTURAL ANALYSIS:- Analysis of determinate structures - different methods including graphical methods. Analysis of indeterminate skeletal frames - moment distribution, slope deflection, stiffness and force methods, energy methods, Muller-Breslau principle and application. Plastic analysis of indeterminate beams and simple frames - shape factors. Basic concepts of matrix method of structural analysis.

3. DESIGN OF CONCRETE STRUCTURES:- Limit state design for bending, shear, axial compression and combined forces. Codal provisions for slabs, beams, walls and footings.

Principles of prestressed concrete design, materials, methods of prestressing, losses. Design of simple members.

4. DESIGN OF STEEL STRUCTURES (Based on Limit State Method):- Analysis and design of tension and compression members, Column bases, Connections- simple and eccentric beam-column connections. Plate girders and trusses.

5. BUILDING MATERIALS AND BUILDING CONSTRUCTION:-

(a) Building Materials:- **Cement:** Components, different types, setting times, strength. **Cement Mortar:** Ingredients, proportions, water demand, mortars for plastering and masonry.

Concrete: Importance of W/C Ratio, Strength, ingredients including admixtures, workability, testing for strength, non-destructive testing, mix design methods. **Bricks:** Types, Indian Standard classification, absorption, saturation factor, strength in masonry.

(b) Building Construction:- Types of Foundations, Brick masonry, Stone masonry, Floorings, Causes and prevention of cracks in buildings, Damp proofing, Special maintenance of buildings.

7. WATER RESOURCES AND HYDRAULIC ENGINEERING:-

(a) Irrigation Engineering:- Consumptive use of water, irrigation systems, water demand assessment; Storages and their yields, ground water and well hydraulics; Waterlogging, drainage design; Design of rigid boundary canals, Lacey's and Tractive force concepts in canal design, lining of canals; Sediment transport in canals; Forces acting on gravity dams and their design, Design of headworks, distribution works, falls, Cross-drainage works, outlets; River training

(b) Hydrology:- Hydrological cycle, precipitation and related data analyses, Probable maximum precipitation, unit hydrograph and synthetic unit hydrographs; Evaporation and transpiration; Floods and their management, Design Flood, Streams and their gauging; Routing of floods; Capacity of Reservoirs.
