Note: - 1. The candidate securing minimum 35 marks each in Part-A and Part-B will be eligible for inclusion in the engagement list of Engineering Associates (Civil, electrical and Horticulture). The final cut-off list for engagement will be prepared on the basis of total marks (70 marks and above) obtained by the candidates.

Tenure of Engagement:

- (i) The candidates who will be willing to work in any municipality or at any other office under the control of Urban Local Bodies Department in the State shall be engaged initially for a period of one year which may be further extended upto three years based on year to year satisfactory performance of the individual Expert.
- (ii) The candidates will provide their choice for three places of posting.
- (iii) Either party may terminate the engagement by giving a mandatory minimum of 30 days notice to each.
- (iv) The contractual services will be liable for termination at any time before the expiry of the contract period on account of poor performance or misconduct or as per requirement, by serving 30 days written notice.

Selection Procedure:

- (i) The applications will be scrutinized at Directorate Urban Local Bodies level by a committee and candidates will be shortlisted based on merits.
- (ii) The written test of shortlisted candidates will be conducted through a reputed Government agency, Government controlled agency or any institution selected by the department.
- (iii) Preference will be given to the candidates having Doctor of Philosophy (PhD), Master's Degree or Toppers of Bachelor's Degree in the prescribed streams only.
- (iv) The decision of the department will be final and no further correspondence will be entertained in this regard.

The interested and eligible candidates shall have to submit their applications online only on the link <https://recruitment.ulbharyana.gov.in> up to 06th August, 2026. No physical application shall be entertained for such engagement.

1. Latest passport size colored photograph. Photograph must be a recent passport size colour photograph with light background and covering 80% of the candidate's face.
2. **Scanned copy of signature of the applicant as per specification given below: -**
 - a. The applicant has to sign on white paper with Black Ink pen. Please crop the portion of signature from the scanned document and upload it in the application form
 - b. The applicants must sign clearly so that the scanned image is clear and may be used for verification at a later stage.
3. Self-certified copy of the Detailed Marksheet Certificate/Degree qualification. However, the candidate having Marksheet/Degree qualification containing GPA/COPA shall upload both sides of his Marksheet/Degree qualification.
4. Self-certified copy of the experience certificate(s).

IMPORTANT INSTRUCTIONS FOR FILLING ONLINE APPLICATION FORM

1. Only online application submitted before the closing date will be accepted. Application form sent in any other form will not be entertained and deemed to be rejected.
2. The application complete in all respects will be accepted and application submitted without photograph/signature will be summarily rejected.
3. It is the responsibility of the applicant to ensure that all the details are successfully submitted online before the closing date. Department will not be responsible for any of the unforeseen circumstances.
4. Applicants, in their own interest, should check their eligibility for specific post before applying.
5. If any candidate submits fake documents/certificates and the same is observed at any stage of their engagement, strict legal action as per law will be initiated against such candidate which may include severing of their engagement.
